Years T-12

ENROLMENT

Enrolment Application Fee

A non-refundable \$140 Enrolment Application Fee is payable at the time of submitting the Enrolment Agreement Form for your child/ren.

Enrolment Acceptance Bond

A refundable Enrolment Acceptance Bond of \$300 per student is required to be paid at the time of accepting an offer of a place at the College. This Bond will confirm the student's enrolment and will be refunded when the student leaves the College if all monies owing have been paid in full and one school term notice of withdrawal is given. The bond will be forfeited if the student's enrolment is cancelled prior to commencement.

Sibling Discounts

Discounts apply on tuition fees only as follows:

- 20% for the second child
- 35% for the third child
- 75% for the fourth and subsequent children

The oldest child enrolled at the College is treated as the first child for the purpose of calculating sibling discounts.

LEVIES

The following levies are charged in addition to tuition fees.

Year 6 Canberra Trip and Years 7-9 Camps

The Year 6 Canberra Trip and Middle School camps are an integral part of a student's education at Good Shepherd Lutheran College and are compulsory. Any request for credit for non-attendance is to be made in writing to the Principal at least two weeks prior to the camp's intended departure and accompanied by a medical certificate.

Year 10-12 Camps (Optional)

Camps may be offered to Years 10-12 students who choose to attend an experience that suits their needs, pursuits and career interests. These camp fees will be advised during the year and are not invoiced on the Annual Fee Statement. Fee accounts must be in good standing for students to participate in these camps.

Inter-Campus Bus Fare (Optional)

The College provides a private bus service between the three campuses to assist families with the safe transportation of students to and from school and the convenience of a single drop off/pick up. Families wishing to use this service should contact Student Services to book their seat(s) and pay the relevant fare. Fares are a flat rate per student per term based on the booking and are not pro-rated or refundable.

One trip per day	\$90 (incl. GST) per school term
Two trips per day	\$170 (incl. GST) per school term

Building Fund Donation (Optional)

An optional tax-deductible donation of \$200 to the Building Fund is included on the Annual Fee Statement. This is an important part of the overall revenue required for the development of the College and families are encouraged to contribute in this way.

Other Fees & Charges (Optional)

Additional fees and charges are payable directly to the College during the year for optional participation in extra-curricular activities such as school sports events, private music lessons, special school performances and replacement stationery.

PAYMENTS

Fees and compulsory levies are invoiced annually and are payable within 14 days, or as otherwise agreed.

Payments may be made by:

- bank transfer;
- direct debit agreement through the College's PaySmart system;
- NT Government payroll deduction for NT Government employees; or
- other arrangement as agreed with the Finance Office.

A 3% discount on tuition fees will apply to accounts paid in full before the end of Term 1 (7 April 2024).

Although the classroom teaching period for Year 12 students is completed earlier than the other year levels, full fees as stated in this schedule apply and must be paid in full.

Senior School students who learn off-campus for one or more days each week are enrolled as full-time students and full fees apply.

Account in Good Standing

An account is in good standing when:

- all fees and charges have been paid in full;
- there is a direct debit agreement in place which covers the annual fees and there have been no breaches in that agreement; or
- an alternative fee payment arrangement is in place and there have been no breaches in that arrangement.

Students are not eligible to participate in extra-curricular activities such as camps and excursions unless the account is in good standing. Where an account is not in good standing, action will be taken to rectify the situation.

Temporary Fee Assistance (TFA)

Good Shepherd Lutheran College strives to support families and minimise learning disruptions during times of unforeseen personal financial stress. Affected families are encouraged to contact the College early to discuss their situation, and may wish to apply for Temporary Fee Assistance.
